Wisconsin Democracy Campaign by its executive director, Matthew Rothschild

I, \_\_\_\_\_, allege that:

The State Senate Democratic Committee (SSDC) misreported and accepted excessive corporate contributions in 2019. The SSDC accepted

---

three corporate contributions totaling \$36,000 from the Democratic Legislative Campaign Committee (DLCC), which is a 527 organization

---

that operates no state or federal PACs. Two of the \$12,000 contributions, which exceeded the state's annual \$12,000 limit on corporate

---

contributions, were posted in the SSDC's regular campaign account rather than its segregated account. A third \$12,000 contribution from the DLCC was properly

---

posted in the SSDC's segregated fund. See attachments - #1, #2, and #3 are relevant pages from three SSDC reports that show the DLCC contributions. Attachment #4

---

is relevant pages from the DLCC's 527 reports that show two of the three SSDC contributions. The third DLCC contribution to the SSDC on 12/12/19 could not be found in the DLCC's 527 report.

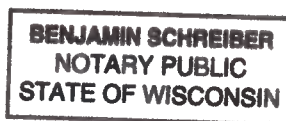
