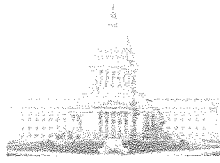

This letter is to notify the Ethics & Accountability Division of the Wisconsin Government Accountability Board of expenses paid pursuant to Wis. Stats. Secs. 19.44 and 19.56.

I received a scholarship to attend a meeting of the Great Lakes Legislative Caucus (GLLC) from July 23-July 25, 2014 in Quebec City, Quebec, Canada. The GLLC is a non-partisan group of legislators from eight states and two Canadian provinces focused on Great Lakes issues. The Midwestern office of the Council on State Governments provides staffing for the GLLC. The address of the GLLC is 701 East 22<sup>nd</sup> Street, Lombard, IL 60148.

The scholarship included the partial cost of lodging. The travel to and from Canada, and other travel fees within Canada, were not covered by the GLLC. The trip entailed sessions on environmental policy. I was also elected the 2015-2016 Chair of the GLLC at this meeting. The total estimated value of expenses paid for by the GLLC/Council on State Governments was approximately \$600.

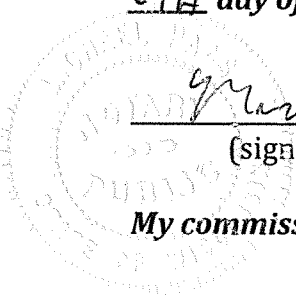
